Alan I Marcus is Professor of History and Director of the Center for Historical Studies of Technology and Science at Iowa State University. He is the author of *Agricultural Science and the Quest for Legitimacy: Farmers, Agricultural Colleges and Experiment Stations, 1870-1890* (1985); *Plague of Strangers: City and Nation and the Provision of Municipal Social Services, Cincinnati, 1819-1870* (forthcoming); and co-author (with Howard P. Segal) of *Technology in America: A Brief History* (1989). He is presently completing a booklength manuscript tentatively entitled "Cancer in Beef: DES, Scientists and the Rise of Modern Food Regulation in America."


Zane L. Miller is the author of books and articles on American urban history, including *Boss Cox's Cincinnati: Physician to the West* (with Henry D. Shapiro); *Suburb; The Urbanization of Modern America* (with Patricia Mooney Melvin); *The Planning Partnership* (with Thomas Jenkins); and *American Urbanism* (with Howard Gillette, Jr.). He is Professor of History and Co-Director, Center for Neighborhood and Community Studies, University of Cincinnati; co-editor of the *Urban Life and Urban Landscape Series*, Ohio State University Press (with Henry D. Shapiro) and of the *Greater Cincinnati Bicentennial History Series*, University of Illinois Press (with Gene D. Lewis).

Patricia Spain Ward, Campus Historian at The University of Illinois at Chicago, is the author of a comparative study of Richard Clarke Cabot and Hugh Cabot; a historian of the Krebiozen cancer controversy; a study of the impact of Abraham Flexner's survey of medical schools on the medical profession in Illinois; and a history of women in pharmacy. Her biography of Simon Baruch (1840-1921), a medical reformer and founder of physical medicine, is forthcoming. She is currently writing histories of The University of Illinois at Chicago College of Medicine and The University of Illinois at Chicago.

Working chronologically, from 1650 to the present, the authors analyze building in North Carolina as a craft, an industry, and a profession. They discuss the wide range of people who produced the state’s built landscape, from local artisans, contractors, and carpenters to celebrated architects.

By the end of the nineteenth century, industrialization and mechanization had changed the centuries-old process of building all across America. Although North Carolina responded to the same changes in labor relationships and construction technologies that affected other parts of the country, the practice of building in the state developed in unique ways that reflect the region’s traditional, rural culture.
