Articles are invited for HUSSERL STUDIES, a new international journal, edited by J.N. Mohanty and Karl Schuhmann, and published by Martinus Nijhoff Publishers. The first issue is scheduled for the fall of 1983.

HUSSERL STUDIES intends to bring out the relevance of Husserl's phenomenology for the contemporary philosophical as well as the wider intellectual situation. It will encourage that interpretive and/or comparative works be solidly based on adequate textual researches into Husserl's writings. In effect, the journal aims at being just the sort of forum for international Husserlian studies, both systematic and historical, that is now needed after many important texts from Husserl's Nachlass have been published. Intercultural and interdisciplinary work will also be encouraged.

HUSSERL STUDIES will also contain critical reviews of current Husserl literature as well as of such philosophical works which have a direct bearing on Husserl Studies. Occasionally, material either Husserl himself or connected with the historical background of his thought may be published in the journal. also be a section devoted to news from the There will various phenomenological centres and societies and sub-scribers will, of course, be kept informed about the Husserliana Gesamtausgabe by the Husserl Archives Louvain.

The Board of officers of The American Philosophical Association is pleased to announce the seventh prize competition funded by the Matchette Foundation. The nature of and conditions for the prize are as follows:

A prize awarded biennially for work of outstanding philosophic merit published since the closing date of the last competition. The prize would normally be awarded to the author of a book. It could, however, be awarded to the author of a number of closely related articles or even of a single exceptionally distinguished article. Decided preference is to be given to the work of younger philosophers. ("Younger philosophers" in this context means persons under forty years of age.) Those submitting nominations should state the date of the author's birth.

The amount of the prize is \$5,000. The Board deeply appreciates the Matchette Foundation's continued

support for this distinguished prize.

Works to be considered for the prize must be nominated by two members of the APA, other than the author (who need not be an APA member). Authors should not hesitate to submit their own publications for consideration, provided that letters of nomination from two other persons who are APA members are obtained. The list of APA members is in <u>Proceedings and Addresses of the American Philosophical Association</u> (Volume 56, Number 1, September 1982). The present competition is restricted to books and articles bearing an imprint of 1981 or 1982. Those making nominations should insure that two copies of the work upon the basis of which the nomination is made be sent to the Executive Secretary. In the case of books, they may do this by requesting the publisher to send the copies.

The nominations will be reviewed by a committee to be appointed by the Association's Board of Officers. Nominations must be received by September 1, 1983. All
