Manuscripts may be submitted in English, Portuguese, or Spanish, must conform to the Modern Language Association *Style Sheet*, and should be sent to the Editors at the Center of Latin American Studies with a stamped envelope for return.

Scholars may, without prior permission, quote from the *Review* to document their own work, but it is their responsibility to make proper acknowledgement and to limit quotation to what is legitimately needed. This waiver does not extend to the quotation of substantial parts of the articles or to a quotation presented as primary material for its own sake. Requests for permission to reprint all or substantial parts of articles should be made to the publisher, Center of Latin American Studies, The University of Kansas, Lawrence, Kansas 66044. A statement of permission from the author should accompany such requests.
